- Form a team of 10 to 15 players (Ages 20 & up and at least 8 with college experience)

- Secure a gym for your team home games & practices
- You & Your Organization's Commitment

Participation Agreement

Non-Compete Clause

And afterwards agree not to directly or indirectly compete with the business of the UMBL, nor solicit UMBL member teams.

The term "not compete" as used herein shall mean that the undersigned shall not own, manage, operate, consult or to be employee in a business substantially similar to or competitive with the present business of the UMBL or such other business activity in which the UMBL may substantially engage during the term of the its season.

The undersigned acknowledges that the UMBL shall or may in reliance of this agreement provide access to trade secrets, customers and other confidential data in good will. The undersigned agrees to retain said information as confidential and not to use said information on his or her own behalf or disclose it to any third party.

Slander
